Chairman David DURFF motioned to approve Resolution 2013- 05 supporting the ALS and BLS in South Newton Township, Supervisor Leroy BOWERMASTER seconded, motion carried.

Supervisor Leroy BOWERMASTER motioned to accept the minutes of November 19, 2013, Supervisor Glenn KEEFER seconded, the motion passed.

Chairman David DURFF motioned to accept the Roadmaster Report, Supervisor Leroy BOWERMASTER seconded, the motion carried.

Solicitor McKnight review the letter sent to J. Wall regarding the failure to obtain septic permit and payment of fees. This is to be paid by December 30, 2013, or further action will be taken.

Solicitor McKnight will have staff person Johanna, research the records for the previous EIT Ordinance for the township.

8. CODE ENFORCEMENT OFFICER (CEO) -

Ms. Dietch was present for the meeting, and addressed the Board regarding the letter she received dated December 3, 2013, requesting the chickens be removed from the property. Ms. Dietch stated that she was sorry that the chickens were still roaming after two weeks, as she thought she had until this meeting to have them secured in a coop. Chairman DURFF reminded her that the agreement was that all chickens needed to be caught and placed in the coop, and the Code Enforcement Officer observed that this request was not adhered to.

Code Enforcement Officer did report that the footage was a little over 9' on the sides. After much discussion, Supervisor Glenn KEEFER motioned to allow the chickens to remove on the property, with the condition that they remain in the coop, and if any other incidences regarding the chickens are report, the chickens MUST be removed. Supervisor Leroy BOWERMASTER seconded, motion carried.
