The South Newton Township (SNT) Board of Supervisors (BOS) met at the South Newton Township Building, 11High Mountain Road, Shippensburg, PA. Chairman David **Durff** called the meeting to order at 7:00 p.m. with the pledge of allegiance. Board members present were Chairman David **Durff**, Supervisor Glenn **Keefer**, and Solicitor Marcus **McKnight**.

PUBLIC COMMENT – Conditional Use Hearing – Abram Zimmerman

A Conditional Use Hearing was held regarding the application of Abram Zimmerman, who has submitted an application to open a home business on High Mountain Road. Mr. Zimmerman stated that this business would be a gunsmith hobby shop, store to sale rifles, hand guns, ammo and targets. The hours would be Monday – Friday 7:00 p.m. – 9:00 p.m. and Saturday 8-5, no Sunday hours. He would place a sign along the right side of the lane, 30 x 40, one (1) sign. There will be no rifle range open to the public.

Testimony was received from approximately 14 residents. The concern most voiced from the residents, was the possibility of a shooting range. Mr. Zimmerman explained there will be no shooting range, for public use. He will have a range for himself to practice shoot and check guns that he repairs. No public will have access to the range.

The Board decided to table the decision on the Conditional Use Hearing until next month, after the Zoning Officer can check on the property regarding the shop and range.

A resident expressed concern regarding the bears that have been roaming the neighborhood. Seems they are remaining in area and not just moving through. Chairman Durff stated that they should call the Game Commission.

13. SECRETARYS COMMENTS - Secretary Durff reviewed the information in the packets with the Board regarding Act 172 of 2016.

The Cargill quote was received. It was decided to request the same amount to be held from 2016 for 2017. Secretary Durff will sign and fax back.

Key 13 was not signed out. After checking with Chief Burkett, Key 13 is in the knox box. Leroy has returned his key and Sunoco card.

Chairman Durff stated that currently there is a \$50.00 per permit reimbursement rate to the Zoning Officer when completing a permit. This is not covering the costs of the hourly rate, so he proposed to increase the base rate of the permit fee from \$50.00 to \$75.00, keeping all other costs associated with the permits the same.

On a motion made by Chairman DURFF the base fee will be increased to \$75.00 for the permit, effective June 20, 2017, Supervisor Glenn KEEFER seconded, motion carried.

Chairman Durff inquired to the Zoning Officer if 267 High Mountain Road has obtained a permit? ZO stated no they have not. Concrete trucks have been delivering. Chairman will contact the Zoning Officer to make a visit.

Chairman Durff asked if a copy of the 36 Maple Avenue letter was sent to Chief Burkett? Solicitor McKnight stated he will send a copy.

Chairman Durff stated he called regarding the Dodge Ram and the spring issue. All suggestions from manufacture were completed. Pictures and documentation were sent, awaiting a decision.

Chairman Durff inquired to the status of the Debit Card and Sunoco Card. Secretary Durff stated they were ordered, but not received yet.

Chairman Durff inquired on the due date of the Recycling Grant. Secretary Durff stated she thought September, but will check and let him know.

Solicitor McKnight stated the County Convention will be held at North Newton Township this year.

Chairman Durff stated that the Dog Warden has been contacted and will be proceeding further with the issue at 22 Maple Avenue.

The white dog at 48 Horsekiller Road has bit someone, and has been reported to the Dog Warden as well. The dog must always be on a leash. If seen without, please contact the Dog Warden.

Supervisor Glenn KEEFER appointed Chairman Durff as Roadmaster, due to the resignation of Leroy Bowermaster.
